All contractors must provide adequate proof of workers compensation and general liability for all employees and equipment of the contractor. All contractors must provide a drug and alcohol-free workplace and comply with the City of Ringgold's drug policy. Contractor is to provide all labor, equipment and materials for entire project. Contractor is to provide all traffic control.

All bidders must be Pre-Qualified with the Georgia Department of Transportation (GDOT) and all subcontractors must be registered with GDOT. Qualifications of the Bidder will be reviewed before the Award of the Contract. The Successful Bidder will be required to furnish performance and payment bonds with the executed Agreement meeting the requirements of the Contract Documents. The City may consider Award of the Contract to other than the low Bidder.
